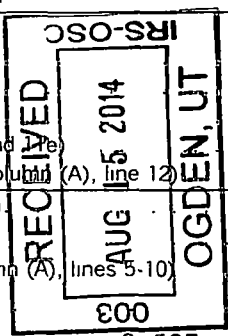

Aspire Education Project was founded as a nonprofit in the fall of 2005 in order to bring high quality supplementary academic support to students who do not readily have access to private tutoring. We provide academic tutoring and standardized test preparation to students in their homes, at after-school centers and in partnership with other organizations. We also manage the Community Reading Buddies literacy program.

OUR MISSION

Because better education builds communities, increases economic potential and enriches lives, Aspire Education Project is dedicated to providing the best academic support to all K-12 students. In order to make a lasting impact, our educators build relationships with students, model lifelong learning and empower those they teach to educate others.

2013 Accomplishments

AEP's current model relies heavily on our fee for service work: we charge competitive market rates for one-on-one tutoring and test prep classes in private schools that can afford it. We pay tutors well and operate in many ways like a for-profit business. Any "profit" that is generated, however, is used to fund other programming that we do at or below cost. These programs include rate reductions for individual students that have demonstrated financial hardship, and test prep classes at schools or other nonprofit organizations supporting underprivileged students. In 2013, there were approximately 471 students receiving services from us, 393 of whom received services for free or at reduced cost. Of these, 263 were students attending workshops

(generally multiday workshops to improve scores on the ACT or SAT), 104 were preschoolers received eight weeks of early literacy work over the summer with our Community Reading Buddies program, and 26 were students who received ongoing one-on-one help, generally weekly, from a tutor. In addition, we consider ourselves to have served in the development of over 100 'youth mentors' in the Community Reading Buddies program, by fostering their sense of responsibility and mentorship towards their 'buddies,' and helping to connect them with underserved parts of their community.

Workshops were held at and in collaboration with the following institutions: Talent Search and Upward Bound (of the Federal Trio Program), MetWest High School, June Jordan School for Equity, and Girls Inc.

Our commitment to providing the highest quality services to all students regardless of ability to pay bore fruit in several inspiring cases, where we helped students make a successful transition to college the way that only an experienced mentor helping one-on-one can achieve. Spencer Brown's mother came to Aspire Education in May of 2013. She expressed concern that her son - a bright and athletic student of color - was going to be caught off guard by the ACT. She knew that many of his peers were getting expensive one-on-one help to boost scores, and she didn't want Spencer to be left behind.

After an evaluation of the family's financial need, we at Aspire awarded a generous scholarship and connected Spencer with Emma, one of its many experienced tutors. As with many of our students, Spencer needed help not only with the content of the ACT, but with also with basic study skills, organization, and figuring out good reasons to put his mind to this threatening and unfamiliar test in the first place. They connected quickly over a mutual love of basketball, and took it from there.

However, Aspire identified his real strength to be in writing, and so we also began a series of sessions to assist with his college admissions essay. He ended up producing a very strong piece of work, and growing in the process. Looking back at his improved score and solid college applications, Spencer reflected that "before this all I was thinking about was basketball and girls. Now I'm thinking about college."
