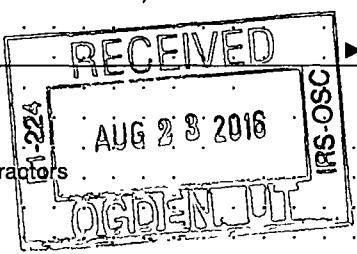

Box B of the heading---Amended Return, reason for and description of the amendments.

While preparing the 2015 990 EZ form, it was discovered that there were several errors on the 2013 990 EZ form which carried over to the 2014 form. These errors appear to be the result of a misreading of a financial report. The 2013 and 2014 990 EZ forms are being amended.

The amendments for the 2013 form are as follows:
