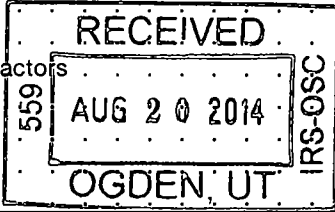



Part 1, line 8: This is income from a car accident settlement, and rental of movie equipment assets acquired for our own movie production which was also rented out to other parties. It is not clear to me if this is "unrelated" business income as referred to in Part IV, line 35(a), and a form 990-T would not seem to apply.

Part 1, line 16: Other expenses are mostly a combination of movie production and promotional expenses (see Part 3, line 29), and usual operating expenses for our internet servers and related expenses.

Part 2, line 22: This includes cash still at least partially at jeopardy due to the bankruptcy of PFGBest, where this cash was supposed to be held in a segregated customer account, but where the CEO of PFGBest converted those funds. There has been a partial recovery, and two legal actions have been commenced to try to achieve collateral recovery, so this is not yet being written off.

Part 2, line 24: Other assets are primarily movie production and computer equipment used in our movie productions and internet activities
