In 2013 CICAS worked independently to design the next generation surgical ablation systems by utilizing dynamic sources of imaging (i.e., Ultrasound Imaging) as means for interactive intra-operative guidance of minimally invasive surgical tools to the targeted pathology. The research involving Ultrasound navigation has yielded an early stage functional prototype illustrating the feasibility of dynamic and automated surgical guidance in soft moving tissue such as for the treatment of cancer lesions in the lung.

CICAS was presented in five conferences and published one peer reviewed journal article during 2013. CICAS also participated as 2 panel chairs and 2 conference scientific chairs in 2013. Dr. Shahidi, the organization's president, was awarded the Satava award from the National Library of Medicine.
