The conference was organized by the ACBS Board, Executive Director, and volunteer committees. This conference served to advance the science of psychology through a forum of presentations, workshops, and discussions. It aided psychologists and other mental health professionals in understanding principles that can be used to help their patients/clients. This conference drew approximately 708 attendees from around the world. This activity was funded through conference registration fees.**
