Chances for Children works to strengthen families and communities to provide a future and hope for the children of Haiti. The organization has two community development programs - located in Kenscoff and L'Artibonit. These communities are built to provide support to families. In Kenscoff, the community begins with the church which has 400 families. These families are served through Chances for Children's efforts that include: a pediatric medical clinic for the community, schools for children to attend, an orphanage to address the orphan population, economic programs for women, and feeding programs for families. In L'Artibonit the community project includes a church and feeding programs and will grow in the upcoming years.

4b (Code) (Expenses \$ 21,216. including grants of \$ 19,822.) (Revenue \$ 19,659.)

Chances for Children works to eliminate poverty AND the orphan epidemic in Haiti. Starting by building churches and communities centered in faith - through these efforts the organization is able to build up families. By providing parents support through schools and feeding programs families are able to keep and care for their children. By providing women with the opportunity to earn an income through the women's empowerment programs they are able to care for their children. These efforts mean less orphans, less desperation for parents, and less crime.

Chances for Children is helping create a sustainable community project located in the rural area of Kenscoff, Haiti. The goal is to provide the community with the following components:

In connection with any actual or possible conflict of interest, an interested person must disclose the existence of the financial interest and be given the opportunity to disclose all material facts to the directors and members of committees with governing board delegated powers considering the proposed transaction or arrangement.

b. Determining Whether a Conflict of Interest Exists. After disclosure of the financial interest and all material facts, and after any discussion with the interested person, he/she shall leave the governing board or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining board or committee members shall decide if a conflict of interest exists.

c. Procedures for Addressing the Conflict of Interest. An interested person may make a presentation at the governing board or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement involving the possible conflict of interest.

The chairperson of the governing board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement.
