While the Elsa M. Heisel Sule Foundation (EMHSF) utilizes the services of outside professionals (e.g. accountants and tax advisors, investment managers, and attorneys) to help meet its needs, it does so on a limited basis.

Virtually all of the day-to-day tasks at EMHSF are completed by its Trustee, V. Ruth Klette or its one (1) part-time support person, Bridget B. Kremer.

The Trustee is directly and solely responsible for keeping EMHSF on-track and for ensuring that its Leadership, Administrative and Programmatic activities achieve that end.

In general terms, the EMHSF's Trustee must deliver substantial value along several broad fronts:

- ▶ The Trustee manage the Foundation's investment portfolios and in doing so they must tract and investigate evolving approaches to money management, and must make every effort to utilize the best of those approaches whenever practicable. To maximize the production of income and safety of assets.
- ▶ The Trustee monitors, analyzes and interprets short-term and long-term trends in the relevant financial markets, and acts upon those trends in a timely and responsible way.
- ▶ The Trustee develops a clear philanthropic agenda for EMHSF, and makes certain that every dimension of that agenda is supported by an appropriate set of initiatives: Trustee develops and implements the required initiatives in a consistently, timely, focused and cost-effective manner. The Trustee developed and maintains the Grant and Evaluation processes and maintains personal contact will all Grantees on at least an annual basis. The Trustee attends, along with various advisory board members, various philanthropic national, regional and local conferences to gain a better working understanding of the grant process and grantees' requirements and to maintain professional competence in issues of legal, tax and regulations facing private foundations and non-profit organizations
- ▶ On a day-to-day basis, the Trustee designs and executes all policies, plans and program support from a paid advisory team. In more specific terms, EMHSF's Trustee gives close and continuous consideration to the many details that surround and support a wide variety of operational issues and initiatives.
