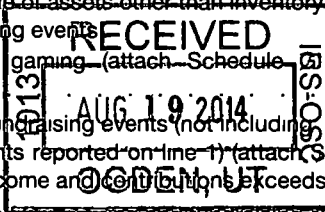

Opened GCL's Shamba A Watoto compound in Kiandutu Kenya, with a feeding program for infants and toddlers, demonstration garden, fuel efficient stove and meeting room.

Launched "Door-Step Gardens Program" using recycled bags in cramped living spaces to grow fresh, healthy vegetables for the family.

Distributed simple water filtration systems in Kenya and El Salvador to reduce the incidence of diarrhea and amoebas in children.

In the United States, GCL is partnering with local schools and community organizations to build Door-Step Gardens in low-income areas (for example, the Montebello School District in California, all of the schools are adding Door-Step Gardens on their grounds), and finally the Mabati Solar Light Bulb Project, which takes used soda or water bottles, fills them with water and a bit of bleach, then glues them into a home's tin roof to create a wonderful solar bulb equivalent to a 55 watt light. Annual family assessments indicate that GCL's programs work. In 2010, a young child in Kiandutu entering GCL ate an average of 1.1 meals per day. A year later, this increased to 1.8 meals per day. GCL also found that from 2010 to 2011, the average income of families helped by GCL increased from about \$2 to \$6 a week. The percentage of parents describing their children as "very hungry" went from more than half to fewer than a quarter after a year. The percentage of children who ate twice or more daily increased from 18% to 63%. Two years later, a longitudinal analysis of 92 assessments collected since 2010 found that family well-being improved with each year of GCL participation.
