First Amendment to Amended Bylaws
Of
The Bernard Foundation

WHEREAS, on or about September 26, 2008, the Board of Directors of The Bernard Foundation, a Texas non-profit corporation (the "Foundation") adopted Amended Bylaws (the "Bylaws"); and

WHEREAS, pursuant to Article 11 of the Bylaws, the Board of Directors desires to amend the Bylaws as hereinafter set forth.

NOW, THEREFORE, the undersigned, being all of the current members of the Board of Directors of the Foundation, hereby adopt the following amendment to the Bylaws, effective immediately:

1. Section 2.02 of the Bylaws (entitled "Number, Qualifications and Tenure of Directors") is hereby amended to add the following provisions:

"Each Director shall serve for a term of one year, and may serve successive terms, without limitation. A majority of Directors shall, at all times, be descendants of George H. Henderson, Sr., unless the Board determines that this requirement cannot be satisfied because there are not enough living adult descendants that are willing and able to serve. At all times, at least one Director must not be a descendant of George H. Henderson, Sr. and must not be related by marriage to any of his descendants."

2. Section 3.07 of the Bylaws is hereby amended to permit checks to be signed by any officer of the Foundation, and to delete the requirement for two signatures as set forth in Section 3.07(d).

This action of the Board of Directors is taken by unanimous written consent pursuant to the provisions of Article 13 of the Certificate of Formation of the Foundation filed in the office of the Secretary of State of Texas on March 1, 2007.

This document may be signed in multiple counterparts, all of which taken together shall constitute a single document.

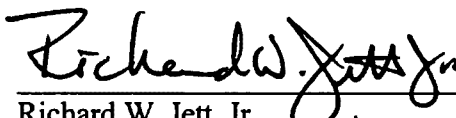
