Resources include, but are not limited to: Grants for project-specific work, grants for general support and organizational development, fundraising support, including trainings and resource development, consulting for planning, policy or technical help, trainings for board and staff development, media and communications training, restoration projects and participation at our annual conference, the Friends Grassroots Network Rendezvous.

National Monuments Campaign The Conservation Lands Foundation is leading efforts to permanently protect naturally, culturally and historically significant public lands around the West.
