Improving People's Health United Way of Central Jersey focuses on evidence-based, best and promising practices and strategies designed to achieve specific goals in the area of health and well-being UWCJ is an official replication site for the nationally acclaimed Nurse-Family Partnership Program through which home visiting professional nurses reach 150 low-income, first-time pregnant moms assuring high-quality pre-natal care, significantly improved birth outcomes and for the newborn infant, ultimate success in school and later life UWCJ is a Center for Medicaid and Medicare Services statewide "Champion" recognized for its leadership role in educational and advocacy efforts actively promoting and facilitating access to affordable preventative, ameliorative health care especially targeting low-income, high-risk populations, including immigrants

Education Helping Children and Youth achieve their potential United Way of Central Jersey directly provides and financially supports a broad continuum of quality pre-school, kindergarten and early grade educational initiatives Specific programs include the widely lauded, evidenced based Parent-Child Home Program, the only such replication site in New Jersey for this initiative in which trained home visitors bring books and toys into the home demonstrating and modeling positive parent-child interaction in 2013,UWCJ was able to expand the parent-child home program via funding provided by a National Corporation of Community Service grant, and services provided by Americorps service volunteers working toward their own educational grant awards UWCJ is also engaged, through its Quality Initiative, in assisting center based pre-school programs achieve accreditation by the National Association for the Education of Young Children (NAEYC) In order to improve opportunities for youth and success in school, the UWCJ supported Pre-Kindergarten Academy and Discovery Afterschool Club both, of which focus on assuring that children are reading at grade level by the end of the third grade, a widely accepted indicator of success in school and on-time graduation from high school

Promoting Financial Stability and Independence United Way of Central Jersey has been a strong organizational leader in a number of initiatives designed to increase the availability of, and access to, permanent affordable housing in part through its role in founding and continuing support of "Coming Home, Middlesex" a non-profit housing advocacy agency as well as through active participation on the county Housing Continuum of Care Committee Our IRS-supported VITA program offering free tax return preparation services to low-income residents has been instrumental in generating hundreds of thousands of dollars back into the hands of needy working families striving for financial independence UWCJ continues to provide leadership to critical relief recovery efforts aiding survivors in the aftermath of Super Storm Sandy Additionally through in-kind corporate donation management efforts targeting needy families and children, UWCJ has distributed back packs filled with food and school supplies and has provided holiday gifts meeting the itemized "wish lists" submitted by impoverished area residents

FOCUSED SERVICE INITIATIVES Superstorm Sandy Relief and Recovery United Way of Central Jersey assumed a leadership role in late 2012 in developing a collaborative approach to deliver emergency relief and long-term recovery services to Central Jersey individuals and households impacted by Superstorm Sandy (October 2012) Dollar investments into these emergency - response and relief services were initiated in early 2013 Throughout 2013, UWCJ served as the fiscal agent for the Middlesex County Long-Term Recovery Group ('MCLTRG') and as the employer-of-record for MCLTRG staff who provided case management, reconstruction oversight, and mental health service referrals for Middlesex County residents who were victims of the superstorm sandy natural disaster NEW AMERICANS PROGRAM An initiative by United Way of Central Jersey to ascertain the needs of emerging immigrant populations in UWCJ's Central NJ service area, and further, to 'connect' those needs to available resources In 2013, UWCJ continued a strategy to build collaborations amongst agencies and organizations serving emerging immigrant populations VITA Tax Assistance Program United Way of Central Jersey trains volunteers to prepare income tax returns for low-income households/residents in Middlesex County & Franklin township Partnering with other nonprofit service providers serving this population, UWCJ facilitated \$1,847,006 in federal tax refund dollars for low-and-moderate income families, including \$501,699 earned income tax credit (EITC) refunds for low-income families United Way of Central Jersey is the only central New Jersey IRS-certified VITA provider offering free tax-preparation services year-round, and receives and responds to delinquent taxpayer client referrals from the IRS OTHER INITIATIVES STUFF-THE-BUS SCHOOL SUPPLY COLLECTION United Way of Central Jersey collects and distributes backpacks and school supplies to enable lower-income children begin the school year equipped for school success In 2013, UWCJ distributed school supplies valued at \$83,024 HOLIDAY GIFTS-OF-THE-SEASON Working with supportive local corporations and charitable organizations, United Way of Central Jersey collects and distributes 'wish-list' holiday gifts to low-income children and their families in our communities In 2013, the gift distribution was valued at \$70,834 which benefitted 1,059 individuals in 247 families SUMMER EVENTS TICKETS DISTRIBUTION Working on behalf of a local minor-league professional baseball club, UWCJ distributes donated ballgame tickets to local youth & children's organizations In 2013, distributed tickets were valued at \$34,350 FOUNDING SPONSOR, MIDDLESEX COUNTY HOMELESSNESS INITIATIVE United Way of Central Jersey, a founding sponsor of a local 501(c)(3) nonprofit agency organized to oversee implementation of the Middlesex County 10-Year Plan to End Homelessness, continues to support this organization by providing leadership and pro-bono financial management services, valued at \$4,900 FOOD/CLOTHING COLLECTIONS & DISTRIBUTION During the course of the year, UWCJ collects non-perishable items collected during 'food drives' at various supporting local corporate and business partners These non-perishable food items are delivered to Middlesex County's centralized food bank, MC FOODS, which supplies over 75 local food pantries Donated apparel & toiletries are also collected and distributed to local organizations Additionally in 2013, UWCJ facilitated the receipt of large book donation from scholastic books, which in turn were donated to public school districts, public libraries, and non-profit agencies serving low-income children in our communities Value of these distributions in 2013 \$108,542 ADDITIONAL SERVICES TO THE NON-PROFIT COMMUNITY DONOR-CHOICE DESIGNATION FUND-RAISING In addition to programs and services funded through United Way of Central Jersey's Community Investment allocation process, UWCJ provides indirect assistance to the nonprofit community via donor designations made during UWCJ's annual workplace donor campaigns In 2013, UWCJ's fundraising efforts provided \$361,270 donor designations to other nonprofit organizations SPECIAL and EMERGENCY REQUESTS - United Way of Central Jersey provides special grants to non-profits in times of emergency or to allow them to take advantage of a specific opportunity to expand or provide additional services For instance, in 2013, 'special grants' supported additional information and resource services to Superstorm Sandy victims, including legal assistance where needed FACILITIES & OTHER SERVICES United Way of Central Jersey provides technical assistance, no-cost meeting facilities, and 'in-kind' services to local non-profit agencies and organizations UWCJ also provides below-market-rate office space to another community partner non-profit agency
