Part III – Statement of Program Service Accomplishments

4a Early Care & Education Projects

The long-term objectives of these projects are to assure Maine's early childhood system is structured efficiently with policies to best serve Maine's vulnerable infants and toddlers. Efforts are focused on improving the early childhood system to better serve targeted populations, assure integrated programming, maintain and improve quality standards, and develop uniform outcome-based program evaluation.

Policy priorities of the Maine Early Childhood Policy Partnership are

- Quality access for low-income children
- Increasing and diversifying early childhood finance
- Educare as statewide model and policy platform
- State gubernatorial and legislative candidate information and training

Achievements during calendar year 2013 included

- Rejuvenated the Start ME Right Coalition as a means of developing and coordinating a grassroots early childhood policy agenda,
- Explored the creation of a children's caucus in the legislature,
- Developed/coordinated grassroots efforts with providers and parents,
- Developed/used consistent, research-based, messaging about the importance of early childhood care/education and the return on investment,
- Provided advocacy tools and resources to Coalition members, friends and policy-makers

4b Federal and State Policy Projects

The objective of MCA's federal policy project is the education of all stakeholders and policymakers about issues that have an impact on the well-being of children, with the goal of improving outcomes for children. Our focus in 2013 was on public benefit programs (TANF, SNAP, Medicaid), tax credits for families, child welfare policies, health access and early childhood programs. MCA coordinated federal policy work around these issues for the New England Consortium's Poverty Reduction Initiative, a six-state collaborative of child research and policy organizations. We provided information and technical assistance to child advocates in the region on federal legislation, coordinated regional visits to our delegations in DC, and provided data and background materials to our congressional delegation, other policy-makers and the general public.

MCA undertook a broad assessment of the developing changes in Maine's rapidly transforming health delivery landscape, identifying the policy opportunities and risks for Maine's 144,000 children served in Maine's Medicaid and CHIP programs (collectively known as MaineCare). As a result of this work, MCA published the report, "Ensuring Health Coverage for Maine Families with Children in 2014: A Health Policy Brief by the Maine Children's Alliance" in March 2014.

4c Maine KIDS COUNT

Maine KIDS COUNT is part of the national KIDS COUNT network, funded by the Annie E. Casey Foundation to track the status of children across United States. Since 1994, MCA has published the annual Maine KIDS COUNT data book which provides current data on the physical, social, economic and educational well-being of Maine's children.

Policy priorities of the Maine Early Childhood Policy Partnership are:

- Quality access for low-income children
- Increasing and diversifying early childhood finance
- Educare as statewide model and policy platform
- State gubernatorial and legislative candidate information and training

Achievements during calendar year 2012 included:

- Increased funding for Head Start and childcare
- Provided technical assistance and support in the development of increases in philanthropic supports to early childhood,
- Worked with DOE to develop specific child outcomes for the longitudinal data effort,
- Released the 2011 Children's Growth Council School Readiness Report
- Provided data and analysis to legislators upon request,
- Authored and released Head Start in Maine Report, December 2011,
- Facilitated a shared services study group and helped form a statewide shared services advisory committee

4d General Advocacy & Legislative Support

MCA provides data and analysis to policy makers in the Maine State government and legislature on issues affecting children, such as health, Medicaid, oral health, Head Start, home visitation, childcare, and children's safety. MCA re-established Start ME Right, an informal coalition of early childhood education advocates and also worked on state budget matters affecting children's programs.
