CONFERENCE Each year Narcolepsy Network (NN) hosts a conference in a different city which creates a unique gathering for, support, education, awareness building, and networking among people affected by narcolepsy. A selection of workshops, lectures, support forums, energizers and creative activities are some of the offerings at the conference. Graduate students and professionals in health, education, science and government can get a unique perspective on narcolepsy and the effect it has on individuals and families. In 2013, NN hosted the 28th annual conference in Atlanta, Georgia. Over 400 people attended from all over the world. The conference offered special programming for children and young adults with narcolepsy as well as sessions on research treatment and advocacy. The annual membership meeting was held on Saturday, October 19, in Atlanta Georgia

Creation and distribution of educational materials and brochures, maintenance of website, interactive forum discussion and social media outreach. Web traffic averages over 5,000 web hits per month. At least 12 outreach, informational and planning meetings were attended. School nurse and elementary school principal outreach continues, connecting school nurses and administrators with information about narcolepsy. Fun awareness events were also held during the year. The New York Dream Big Walk was attended by over 120 supporters, the First Annual Narcolepsy Bed Race in Virginia was attended by almost 100 people who witnessed 6 teams race beds around a course in a parking lot. Narcolepsy Network joined hundreds of others from the narcolepsy community at the FDA's public meeting on narcolepsy drug development. Each newsletter provides information on diagnosis, effective treatments, resources, updates detailing new narcolepsy research, ideas for coping, personal stories and interviews, industry news, legal and insurance guidance and much more. Approximately 2,000 newsletters are printed quarterly. Support groups assistance is provided to members. NN helps support groups and encourages grassroots outreach and education. Many support groups held picnics and NN was pleased to provide some financial assistance. More than Forty (40) full and partial memberships were provided for those in need.
