THIS PROCESS WAS DOCUMENTED IN VAR IOUS PLACES INCLUDING THE MINUTES AND MEMORANDUMS. THERE WAS NO INCREASE IN SALARY DURING 2012 OR 2013. THE EXECUTIVE DIRECTOR DID, HOWEVER, RECEIVE A BONUS DURING 2013 THAT WAS AP PROVED BY THE BOARD PRESIDENT. THERE ARE NO OTHER OFFICERS OR KEY EMPLOYEES OF THE ORGANIZ ATION, THEREFORE LINE 15B IS ANSWERED "NO"
