APPRENTICES ENROLL FROM AROUND THE COUNTRY AND WORLD IN AN INTENSIVE TWO YEAR PROGRAM THAT TEACHES TRADITIONAL BOATBUILDING AND JOINERY, WHICH IS SUPPLEMENTED BY INSTRUCTION IN SEAMANSHIP AS WELL AS OTHER MARITIME SKILLS AND LEARNING. THESE STUDENTS BUILD VESSELS AS COMMISSIONED BY CLIENTS, AND PARTICIPATE IN WEEKLY SEAMANSHIP/SUPPLEMENTAL INSTRUCTION WHILE ALSO BEING INVOLVED IN THE OPERATION OF THE SCHOOL AS WHOLE.
