The undersigned, as an authorized representative of Ericsson Plan Administrative Committee, as the "Named Fiduciary" of the Telcordia Technologies Welfare Trust (the "Trust") and its related plan (the "Plan"), hereby directs The Bank of New York Mellon, as trustee of the Trust, ("Trustee") to pay \$155,861.50 (the "Reimbursement Amount") from of the Trust (Telcordia Welfare VEBA Cash BEWF17473502), as an expense properly payable from the Trust, to Ericsson, Inc. (the "Company"). The Reimbursement Amount represents a reimbursement to the Company for a direct payment by the Company to a third party insurance company for premiums associated with the Plan and Trust during the month of December, 2013. Thereafter the undersigned hereby further directs the Trustee to pay to itself up to \$12,500.00, representing fees for trustee services, from the remaining assets of the Trust. In this regard, the undersigned understands that after the Reimbursement Amount is paid to the Company the Trust will have less than the \$12,500.00 required to make full payment to the Trustee, and the Company hereby agrees to pay promptly to the Trustee the difference between the amount paid from the Trust and the full amount due the Trustee.

In addition, the undersigned hereby serves notice to terminate the Trust and related Trust agreement with the Trustee effective promptly upon completion of the distributions directed above. The undersigned hereby understands that the Trustee is willing to waive any minimum day notice requirement relating to the termination of the Trust and agreement set forth under the relevant Trust agreement.

2. The relevant Plan document and Trust agreement do not prohibit the payment or reimbursement of expenses from the Trust (including, without limitation, the Reimbursement Amount) nor impose any other restriction that would affect the payment directed hereunder;

4. The Reimbursement Amount is reasonable under the circumstances and has been properly allocated to the Plan and Trust;
5.
