We conduct short term mission trips to India to come along side the church in India to provide training and assist in church planting, village development and child rescue. In 2013, we took 11 teams to India that included a total of approximately 100 volunteers. Revenue and expenses reported on the 2013 cash basis Form 990 include substantial prepayments for 2014 trips.

In village development projects, we empower indigenous pastors with practical resources they need to transform their village spiritually and physically. We provide clean drinking water, sanitation, and food as a means of advancing the gospel. We completed 18 village development projects in 2012 and 12 in 2013.

4c (Code) (Expenses \$ 144,111. including grants of \$ 116,606.) (Revenue \$)

We sponsor, train, and equip native church planters in order to reach unreached people in India with the gospel of Jesus Christ. In 2013, we sponsored 87 church planters.
