New bins are covered to prevent seagulls or wind from dispersing trash across the beach and into the water and have had significant impact on lowering trash on beach and in the water. Continued to provide recycling and trash bins on school athletic fields. Impact estimated at over 20 tons less trash per year sent to landfills. RMF sponsored Green Team led the waste diversion efforts at the 2013 Switchfoot Bro Am, an annual charity surf contest and concert fundraiser held at Moonlight Beach in Encinitas, with approximately 10,000 attendees.
