THE SOCIETY OF VASCULAR AND INTERVENTIONAL NEUROLOGY HAD APPROXIMATELY 170 MEMBER PHYSICIANS DURING 2013. THE SOCIETY HELD ITS ANNUAL MEETING AT THE OMNI HOUSTON HOTEL IN HOUSTON, TEXAS. AFTER THIS MEETING, THE PARTICIPANTS WERE ABLE TO UNDERSTAND THE RESULTS OF RECENT ENDOVASCULAR STROKE TRIALS AND HOW THESE RESULTS IMPACT CURRENT NEUROENDOVASCULAR PRACTICE, IDENTIFY PATIENTS WHO MAY BENEFIT FROM ENDOVASCULAR THERAPY IN INTRACRANIAL ATHEROSCLEROSIS TECHNIQUES TO INTRACRANIAL STENTING, COMPREHEND THE CHANGES IN 2013 CODING AS THEY IMPACT INTERVENTIONAL NEUROLOGY AND IDENTIFY THE PRACTICE MODELS AS THEY CURRENTLY EXIST AND POTENTIAL AREAS OF GROWTH, UNDERSTAND UPCOMING TRIALS AND DESIGNS IN ENDOVASCULAR STROKE AND INTRACRANIAL ATHEROSCLEROSIS AND UNDERSTAND THE IMPACT OF RECENT CLINICAL TRIAL RESULTS ON PROCEDURAL REIMBURSEMENT.
