In 2013, NJ Conservation achieved national land trust accreditation Stewardship In 2013, NJ Conservation completed a Forest Stewardship Plan for the Franklin Parker Preserve, the most ambitious such plan on any privately managed conservation property in New Jersey The trail system at the Apshawaw Preserve in Passaic County was improved by constructing new trails and reorganizing old trails to enhance visitor experience Land Acquisition In 2013, NJ Conservation and its partners permanently preserved nearly 1,800 acres, completing 24 conservation transactions From the Highlands to the Delaware Bay watershed, NJ Conservation preserved productive farms that keep the "garden" in the Garden State, and beautiful natural areas that provide outdoor recreation, protect wildlife habitat and safeguard public drinking water supplies In 2012, NJ Conservation was recognized by the New Jersey Agriculture Development Committee as New Jersey's leading nonprofit for preserving farmland and in 2013, was awarded \$4.75 million from the Federal Farm and Ranchland Protection Program, the most of any nonprofit These capital funds are used to purchase permanent easements on working farms throughout New Jersey Preserving farms not only benefits our State's environment, but is critical to New Jersey's economy Advocacy In 2013 NJ Conservation joined the battle to prevent LG Electronics from building a high rise office tower above the iconic Palisades Allowing this project would set a negative precedent for spoiling natural and historic landmarks An Easement Permanence Project gained momentum, with Byram Township in Sussex County agreeing to participate as the first case study community NJ Conservation worked with partners to advance State legislation asking voters to dedicate a portion of existing corporate business tax revenues to land preservation Education NJ Conservation again hosted the annual New Jersey Land Conservation Rally, one of the nation's largest statewide conservation training events More than two hundred conservationists attended this daylong educational event at Rutgers in New Brunswick, which included nearly 30 workshops and featured a lightning round of speakers highlighting the need for renewed open space funding More than 900 participants enjoyed our signature "Step Into Nature" events, a series of 27 outdoor activities on our preserved lands
