AT THE CONCLUSION OF THE BOARD OF DIRECTOR'S RESPONSE PERIOD, THE AUDIT COMMITTEE WILL CONDUCT A LINE BY LINE REVIEW OF THE RETURN WITH THE FOUNDATION EXECUTIVE DIRECTOR AND CONTROLLER, REVIEW THE COMMENTS, CONCERNS AND QUESTIONS RECEIVED, IF ANY, FROM THE VOTING MEMBERS OF THE BOARD OF DIRECTORS AND MAKE A RECOMMENDATION TO THE FULL BOARD REGARDING THE ACCEPTANCE OR REVISION OF THE 990. IN THE EVENT THE AUDIT COMMITTEE'S REVIEW RESULTS IN RECOMMENDED REVISIONS, THE CHAIR OF THE AUDIT COMMITTEE WILL COMMUNICATE THOSE REVISIONS TO THE AUDITORS FOR FURTHER REVIEW AND CONSIDERATION.
