NATIONALLY, IPIP IS A PROGRAM OF THE AMERICAN BOARD OF MEDICAL SPECIALTIES(ABMS)RESEARCH & EDUCATION FOUNDATION AND FUNDED BY THE ROBERT WOOD JOHNSON FOUNDATION. THE PA IPIP PROGRAM STARTED IN 2007 AND IS LED BY THE PAFP ALONG WITH THE PA CHAPTERS OF THE AMERICAN COLLEGE OF PHYSICIANS & THE AMERICAN ACADEMY OF PEDIATRICS. TOGETHER THE THREE ORGANIZATIONS FORM THE PA PRIMARY CARE COALITION AND REPRESENT MORE THAN 10,000 FAMILY PHYSICIANS, INTERNISTS AND PEDIATRICIANS. IN PENNSYLVANIA, IPIP WORKS IN CONJUNCTION WITH THE PA CHRONIC CARE INITIATIVE, A PROGRAM OF THE GOVERNOR'S OFFICE OF HEALTH CARE REFORM, THE GOAL OF THIS INITIATIVE IS TO ASSIST PRACTICES IN IMPLEMENTING THE "CHRONIC CARE MODEL" INITIALLY FOR ADULT DIABETES AND PEDIATRIC ASTHMA PATIENTS AND TO BECOME PATIENT-CENTERED MEDICAL HOMES.
