Remediation of acid mine drainage in Espy Run and at the Askam Borehole, primarily funded by grants. In addition to the above direct expenditures, there was an additional contribution of \$1,966 in professional services for water quality testing.

4b (Code:) (Expenses \$ 255,365 including grants of \$) (Revenue \$ 77,318)

Multiple projects financed primarily by Earth Conservancy related to the reclamation and return of former coal company-owned land to the region, including the operation of a yard waste composting facility utilized by multiple Luzerne County municipalities. The facility processed approximately 9,000 tons of material, substantially all of which will be used in land reclamation/improvement projects.

4c (Code:) (Expenses \$ 59,262 including grants of \$) (Revenue \$)

Design and development costs relative to the reclamation of Hanover 9, a 300 acre parcel that was a former strip mine site. The project is in the vicinity of Luzerne County Community College and no too far from center city Nanticoke. The project is primarily funded by grants.

Earth Conservancy believes that it is necessary to identify potential conflicts on a timely basis. For this reason, the organization periodically requires that a written Declaration of Affiliation is completed and returned for review by members of the Board of Directors and management, as necessary. Additionally, a written summation of family or business relationships among officers, directors or key employees is obtained.
