In addition, each year, a national classical music performance competition is held which produces revenue from (1) contributions of attendees, (2) fees from the competitors, and (3) ads in the programs. The first of these qualifies as public contributions, reported on Line 1 of the 990, while the last two are reported as fundraising income on Line 6b. For the past two years, because of general economic conditions, we did not hold the competition. This has resulted in decreases in Lines 1 and 6b. We also participate in a township monthly Friday night tour of the business community, called "First Friday", for which we hold a concert. We are able to solicit contributions from the public that may not normally attend our other concerts. Our general public contributions, outside of these special events, has also fallen over the past several years, we believe. With an improving economy, we expect to improve these contributions as well.
