**Form 990, Part VI, Section B, Line 12c** The Board of Directors and employees are required to complete and submit annually a signed Conflict of Interest statement.

**Form 990, Part VI, Section B, Line 15b** The Board of Directors evaluates the Executive Directors and other key employees performances, all other employees are reviewed annually by the Executive Director. The annual reviews are reviewed by the Board of Directors.
