The annual conference, usually held in April of each year, attracts between 650 and 750 student, faculty and other attendees.
This includes students, and faculty from educational, private and governmental institutions around the country, as well as from foreign countries. The conference provides an outlet for scholars to present their work to their peers and an opportunity for that work to be commented on and reviewed. Over 900 papers are presented during the three days of the conference.

Journal Production -----> The Social Science Journal has been published by WSSA since 1963. The copyright for the Journal is owned by the Western Social Science Association. The Journal is currently printed, produced and mailed by Elsevier Publishing who in turn provides the revenue from the sale of the Journal to WSSA. The Journal is distributed to about 800 individuals and over 2,000 institutions. The Journal is published four times per year. It has a 90 percent rejection rate for submissions. About 40 to 45 scholars per year are published in the Journal. The Journal also provides book reviews.
