The 2013 Association for the Sociology of Religion (ASR) annual meeting, held in New York City, New York, August 10-12, on the theme of "Tributaries, Eddies, and Cross-Currents: Religion Outside the Mainstream," included 49 panel sessions during which 152 academic papers were presented, the Presidential Address by Fred Kniss, the 2013 Furfey Lecture by Nancy Ammerman, and 3 receptions. The ASR Executive Council met twice during this meeting, which is the normal expectation. The ASR annual meeting is always held in conjunction with the annual meeting of the American Sociological Association, in the same city. Two of the ASR panel sessions during its program were co-sponsored with the American Sociological Association.

*Grants reported above were given to 16 recipients of ASR's competitive Gallagher Travel Awards designed to provide financial assistance for attending the Annual Meeting.

Publication of: (1) Volume 74 of the quarterly academic journal "Sociology of Religion" in cooperation with Oxford University Press, under the editorship of Scott Schieman. Swatos by Brill, "Testing Pluralism: Globalizing Belief, Localizing Gods," edited by Giuseppe Giordan and William H. Swatos. "Sociology of Religion" contains original research articles, book reviews, and "ASR News & Announcements," which contains informational material as appropriate to each quarter.
