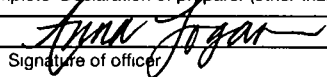

Part II, Line 26. Liabilities consist of receipts from activities from participants to be passed through, along with scholarships awarded, to High Desert Leadership Retreat.

Part III, Line 31. Other Program Services include Horse Shows, a Small Animal Show, and a recognition program.

Part V, Line 33. The organization operates an after-school program which provides a snack, help with homework, mentoring and reading, and recreation activities to explore science-rich activities through Crook County 4-H. The program partners with other local agencies to promote values in alignment with those of 4-H, including competence, confidence, connection, character, and compassion.
