NOCSAE funded research resulting in the publication of more than ten peer-reviewed scientific journal articles on the topic of concussions in sports, injury epidemiology, and equipment performance. In addition, the Center for Injury Research and Policy at Nationwide Children's Hospital in Columbus, Ohio, in affiliation with Ohio State University, maintains a high school sports injury surveillance program and publishes results of that data with significant grant support from NOCSAE.

Establishment of athletic equipment standards through related research. On the basis of grant funded research, and direct contracted research, NOCSAE has drafted three new standards for baseball and softball protective headgear and face gear for defensive players, a youth football helmet standard, and is investigating the feasibility of a lacrosse helmet standard for women.

Enhancement of the integrity of the NOCSAE standards and licensee compliance. This figure includes \$291,629 spent in maintaining and improving the integrity and accuracy of certifications made regarding compliance of specific equipment to the NOCSAE standards, and in modifying certain language in some standards, as well as collecting and reviewing testing certification data from many of its licensees, and in performing direct product testing where evidence was provided of a potential product failure. The total figure also includes \$122,843 apportioned from legal and administrative expenses to the enforcement of license agreement compliance and performance, litigation to enforce termination of noncompliant licensees, and compelling compliance with certain license agreement terms regarding product quality control and quality assurance.

(Code) (Expenses \$ 181,820 including grants of \$ 50,532) (Revenue \$)

NOCSAE continued to support CDC Heads Up to Parents, an online concussion education, training, and prevention program, which includes educational apps for smartphones, and a dedicated website maintained by the CDC which provides educational videos and training programs as well as helmet fit and maintenance information. NOCSAE also contributed \$45,532 towards the youth helmet replacement program developed by the NFL, USA Football, NOCSAE, and NAERA, which involved replacing old helmets in youth football programs in underserved and financially disadvantaged areas in 4 major cities and regions throughout the country. As part of this helmet replacement program, NOCSAE also began to develop an RFID based helmet inventory and tracking program to facilitate regular recertification of helmets.
