**Washington Osteopathic Foundation**  
**2013 Program Service Accomplishments**

Three scholarships in the amount of \$1,000 each were awarded to an osteopathic medical student for osteopathic medical school tuition.

One grant in the amount of \$5,000 was provided to the Northwest Osteopathic Medical Foundation for a 2:1 matching fund to provide a \$10,000 scholarship for an osteopathic medical student from Washington State.

In 2013, thirty-nine students at the Pacific Northwest University of Health Sciences College of Osteopathic Medicine were assisted by the Student Hardship Loan Fund created with WOF funds for a total of \$57,237.69.

The Foundation partnered with Seattle University to host an osteopathic premed forum, with attendees from several colleges and universities in Western Washington. The Foundation provided \$865.05 for expenses.

The Foundation provided six osteopathic medical students with \$10,000 student loans, for a total of \$60,000.

Three CME Scholarships in the amount of \$775 each were awarded for students and residents to attend WOMA CME programs.

Two grants in the amount of \$5,000 each were paid to Washington Osteopathic Medical Association for continuing medical education.
