Five Valleys Land Trust is a not-for-profit, community-supported organization dedicated to protecting scenic open spaces, wildlife habitat, riparian areas, and agricultural lands throughout western Montana We work directly with willing landowners and other partners to craft unique collaborative solutions to conservation challenges and opportunities We believe that protecting western Montana's natural legacy benefits our community now and in the future, and that preserving these places will create a permanent legacy that benefits all living things 2013 Accomplishments2,300 acres in the Mission Valley on working dairy and ranch This easement near Ninepipe National Wildlife Refuge is the largest in the Mission Valley and protects abundant wildlife, diverse bird species, a vital agricultural community, and rich cultural traditions A 160-acre meadow fringed by ponderosa and lodgepole pines north of the town of Lincoln and south of the Bob Marshall/Scapegoat Wilderness complex The Youderian family has been stewarding this land since 1959, watching elk, moose, deer and the occasional grizzly bear wander through the property A pair of sand hill cranes nests in the meadow grasses nearly every year, and Stonewall Creek flows along Youderian Meadow and then south to join the Blackfoot River A conservation easement with the City of Missoula, the National Wildlife Federation, and the Marbut family to provide lasting protection for 27 acres of riparian habitat along Grant Creek The family established the area as a nature reserve in 1979 in honor of Charlotte Reed Marbut With the conservation easement now in place, the family is assured that the property will always be set aside for wildlife Our Route of the Olympian - Saltese project acquired a 4-acre property enabling a six-mile extension of the Route of Olympian bicycle path east from Saltese toward Haugen, MT Ownership of the property will be transferred to the US Forest Service, helping establish a 31-mile trail connection to the popular Route of the Hiawatha trail 171 acres of excellent riparian habitat and timbered hillsides that provide important summer and winter range for elk on Miller Creek 90 acres were purchased adjacent to the 201-acre Rock Creek Confluence Property This narrow property contains the actual confluence of the two rivers and protects 2.5 miles of the Clark Fork River
