

Youth Development Programs Striders provide a youth running program located in four sites (cities) throughout the South Hampton Roads region that includes volunteer coaches who are background-checked. All youth and coaches are provided uniforms as well as equipment and training materials. Club also provides "camperships" which enable area youth runners to attend running camps over the summer. Club also provides scholarships for area runners based on academic & athletic performance and community service. 2013 awards went to ten student-athletes which ranged from \$1,000 - \$3,000 and totaled \$19,000.
