Clinic Services Napa Humane operates a low-cost, high volume, high quality Spay/Neuter Clinic serving companion animals throughout the Napa Valley We perform up to 5,000 surgeries per year with our one surgery suite operating an average of 250 days In addition, Napa Humane is an important link in keeping a healthy population of pets and people by holding an affordable weekly vaccination/microchipping clinic In that 3 5 hour weekly clinic in 2013 we vaccinated 2,288 pets and microchipped 1,746 companion animals

Humane Education Our outreach efforts engage hearts, hands, and minds for animals We are in classrooms each week of the school year with programs such as Responsible Pet Care and Safe with Cats and Dogs We also created a live puppet performance, The Right Pet for Princess Penny, presented in assembly format of 200-400 children per show and provide a curriculum-based activity book to each child to reinforce the humane lessons presented reaching up to 4,000 students a year We sponsor annual subscriptions to KIND News (Kids in Natures Defense) to over 100 classrooms reaching 3,000 students and we offer community classes Introducing Your Pet to your New Baby, Kitten 101, Bunny Basics, and Pet First Aid

Shelter Support Services We use our Mobile Adoption Unit to take animals from the Napa County Animal Shelter out into the community and we help to re-home Shelter pets by leading a cadre of volunteer photographers to take appealing pictures of the animals that show their personalities outside of their caged environment, posting the photos on websites such as Petfinder com to create the most exposure possible for a pet in need of a home Napa Humane uses our resources to assist our municipal shelter in ways that enhance the animals time at the shelter and to shorten their length of stay We accomplish this with economy of scale purchasing, providing capital items outside of the Shelters budget, and creating successful partnerships to augment what the budget might allow
