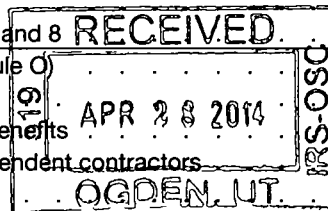

Birthright of Greater Hartford, Inc. offers services, aid and assistance to individuals who have problems with a pregnancy and desire a positive alternative to abortion.

Part III, line 28:

Birthright's volunteer staff also offered community resource information and referrals. Estimate (from previous year) 334 total callers. Of these, 62 community assistance callers and 272 crisis pregnancy callers.

Pregnancy tests provided for 130 women and friendship counseling for 206.

78 babies born to mothers we served. 47 mothers received maternity clothing and 37 babies received baby clothing.

Actual (not estimated): 23 mothers assisted in purchasing cribs and 22 in purchasing car seats. Friendship counseling volunteers staffed the office 35 hrs/wk and clerical and clothing volunteers 16 hrs/wk. Grant of \$10,000 to Birthright, U.S.A. hotline which is staffed 24 hrs/day, 7 days/wk. Grant of \$1,000 to Birthright, International to www.birthright.org website design.
