

Tenant Worker Center (TWC): This program empowers workers and tenants through education and organizing. This year we worked with workers to train them on labor laws to prevent wage theft and exploitation and recover over \$100,000 in stolen wages. We also trained over 20 workers as part of a hospitality vocation training program in skills to attain jobs in the hospitality and service industry. We also educated and trained low income tenants living in single room occupancy hotels on issues such as fire prevention.

Youth Organizing: This program strives to develop youth's leadership skills through their participation in our campaign work. This year, over 30 youth participated. We completed our 4th annual Youth Leadership Retreat, where 28 youth leaders learned about CPA's history and campaigns, and how to build community with each other. During the summer, we trained over 100 low income youth in public speaking, outreach, and event planning. Youth participated in outreach for pushing for better healthcare access for San Francisco.

Leadership Development: Our 4th Cohort of the Eva Lowe Fellowship for Social Justice graduated this summer. This year's fellowship included an overnight orientation retreat and a SF Social Justice tour with our allies. Out of the six fellows, two have secured work with organized labor post graduation while two are pursuing their graduate degrees.

Additionally we conducted voter education and registration and educated thousands of San Franciscans on immigration reform, healthcare access and the Affordable care act.
