Seniors love to come to our center to meet new friends and to participate in the many interesting activities as shown in our monthly newsletter, most of which are provided at no cost or at a nominal donation. Our Center is one of the finest in Southern California.

 HEALTH & NUTRITION. This important program is to provide nutritious meals in our lunchroom and for home delivery to shut-ins. We have exercise equipment in our Fitness Room which is very popular with our members. Our holiday Certificate distributions at Christmas time provide free food to needy seniors. Counseling services are available. Hot lunches are provided each week day. Nutrition and exercise are most important in maintaining good health.

Our Association enjoys free use of a facility (owned by the City of Culver City), that includes meeting rooms, classrooms, office space, fitness room, billiards room, lunchroom, a large parking lot ( for which we collect and keep fees from our membership for parking) The facility is staffed by city employees The City also provides Vans and drivers to transport our members We have estimated the total value of these benefits at \$250,000 anually

Our Association is independent. It is governed by an eleven member Board of Directors ( who serve without compendation) elected by the members and is not controlled by the City Transactions between our Association and the City are at arms length

Each year the Association makes a cash grant to the City to help offset part of the expenses to maintain the facility. For the year 2013 total grants to the city were \$54,598
