Bible translation, literacy, and related mobilization and discipleship activities PBT teams around the world are ministering to 26 million people in 62 different language projects in 14 countries During 2013, PBT personnel processed over 216,000 verses of Scripture from one stage of the translation process to the next, a significant increase from the previous year This includes rough drafts, exegetical check, comprehension check, peer check, consultant check, published, and revised Numerous individual books of the Bible were published, along with other discipleship materials in local languages Audio recordings in local languages were also produced

Recruitment Recruiting new missionaries is key to the mission of PBT The organization had 28 new recruits in 2013 PBT held 16 recruitment events at colleges, churches and other conferences around the U S Through those events, about 2,000 people became aware of the need for Bible Translation and the role PBT plays within this global need About 120 of these are serious inquirers Training new and current missionaries is an integral part of PBT's mission In 2013, personal and professional coaching was provided to 113 individuals preparing for cross-cultural work A ministry practicum and planning course was offered in both the fall and the spring, and weekly chapel services were conducted throughout the year The following workshops and seminars were also provided, training over 300 people during the year Pioneer Missions Institute, Discovery Intensives, Partnership Development, Bush Mechanics and Electronics and Primary Health Care Ongoing training activities continued daily with new recruits and missionaries in transition

Missionary Care PBT has a strong pastoral and counseling ministry It has seven overseas care facilitators, three stateside chaplains, eight stateside pastoral caregivers, and three licensed counselors It also has several volunteers who give much time in providing meals, lodging, and other services for PBT missionaries The Care Department sponsored a Field Workers Reunion, a seminar for the parents of missionaries, a five-day prayer and fasting event for all of PBT in the spring and again in the fall, and a special time of prayer for the summer interns A new prayer program was initiated that has someone in PBT fasting and praying each day of the year Five stateside members of the Care Department made trips overseas to minister to PBT missionaries in five different countries Dozens of pastoral care calls have been made and thousands of pastoral care emails and cards have been sent Twenty-three missionaries have received reentry assistance as they returned on temporary home assignment after completing two years or more in overseas service
