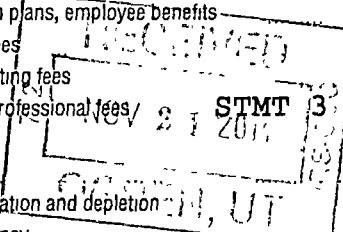

## Textron Matching Gift Guidelines

Textron is committed to responsible corporate citizenship and helping improve the quality of life in communities where our employees live and work. We view our public responsibility as an integral part of our business and actively seek out partnerships with agencies that develop and implement innovative solutions to community needs. The Textron Matching Gift Program provides an opportunity to join with employees in supporting this commitment. The Textron Charitable Trust provides funding for the program.

### Eligible Participants

Any full-time employee or member of the Board of Directors of Textron is eligible to participate. Part-time, temporary and retired employees are not eligible. Neither gifts from spouses and other family members, nor gifts made jointly by several individuals are eligible for matching funds.

### How the Program Works

Textron will match paid contributions between \$25 USD and \$7500 USD per individual, per calendar year, to eligible institutions at a 1:1 ratio, for a maximum Textron contribution of \$7500. An individual may attain their \$7500 limit by giving a one-time \$7500 contribution or by making several smaller gifts. Gifts must be made directly from the employee's/director's own funds to approved eligible organizations.

Contributions must be paid by cash, check or negotiable securities that have a publicly listed market value. The value of securities will be determined based upon the closing market price on the date of the gift. No other form of personal or real property, gifts in-kind, materials, gifts made by will or similar mechanisms or supplies will be matched. Matching gift requests must be registered within 90 days of the date of the gift. Contributions made on or before December 31 will be credited to an individual's limit for that calendar year. All contributions are checked against these guidelines.

### Non- U.S. Matching Gifts

Gifts made in non-U.S. countries must be equivalent to a minimum of \$25 USD. All non-U.S. matching gift payments will be paid to the charity in the local currency of the country the charitable organization is located.

### Eligible Organizations

#### U.S. Organizations

Organizations eligible to receive Textron matching gifts include institutions located in the United States that are recognized by the Internal Revenue Service (IRS) as tax-exempt and designated a public charity under Section 501(c)(3) of the IRS Code.

#### Non- U.S. Organizations

Eligibility guidelines for non U.S. organizations follow the U.S. guidelines. In addition, all non U.S. organizations must be validated to ensure they comply with all U.S. IRS regulations and laws. Non-U.S. organizations will be required to complete validation forms in English and return them to Textron's matching gift administrator.

Matching gift payments will be made after Textron receives the completed validation forms proving that the non-U.S. organization is equivalent to a 501(c)(3) U.S. charitable organization. *(This process may take an extended period of time depending on the charity's timeliness and desire to complete and provide the necessary information for the validation process.)*

### Ineligible Organizations

#### U.S. Organizations

Churches, synagogues, mosques and other institutions that are primarily religious in nature are ineligible for the program. Exceptions include religious organizations that have separate 501(c)(3) designations where the funds are to be used exclusively for a non-denominational social, educational or health service.

#### Non- U.S. Organizations

Eligibility guidelines for non-U.S. organizations mirror the U.S. guidelines.

Churches, synagogues, mosques and other institutions that are primarily religious in nature, except where the organization which benefits from the gift has a separate 501(c)(3) from the religious organization for non-denominational social, educational or health services.

### Ineligible Gifts

Ineligible gifts include amounts payable as:

- Membership dues
- Subscription fees for publications
- Tickets or merchandise purchases
- Charitable contributions made as part of a United Way or employee giving campaign
- Charitable contributions made via payroll deduction
- Payments that cover the cost of services, tuition, books or student fees
- Donations to seminaries and theological schools

- Gifts to organizations that are not tax-exempt under section 501(c)3 of the Internal Revenue Service Code or are otherwise ineligible

- Tickets or merchandise purchases
- Charitable contributions made as part of a United Way or employee giving campaign
- Charitable contributions made via payroll deduction
- Payments that cover the cost of services, tuition, books or student fees

- In-kind services, materials, supplies or pledges
- Gifts made with funds provided to the employee for donation purposes by other individuals (i.e. pooled/group funds)
