The Beth C. Wright Cancer Resource Center awarded grants to people living with cancer to help them cope with the financial stresses that are a result of going through treatment for cancer. People used these grants to help pay their household bills such as heating bills, mortgage payments, rent, and car payments. The grant recipients have also used the funds received to help pay for the costs of travel and housing expenses incurred while receiving treatments for care. The Beth C. Wright Center serves a rural population and people often have to travel hundreds of miles a week to receive their treatments.

The Beth C. Wright center offers a variety of programs and services for people living with cancer and for their family members, caregivers, friends, and interested community members. All of these programs are offered at no charge at our Center in Ellsworth and other locations in Hancock and Washington Counties. These programs include classes in reiki, yoga, therapeutic exercise, reflexology, and other complementary therapies. The Center also facilitates support groups for people living with cancer in Ellsworth and other communities in Down East Maine. This past year we also organized with other partners the Acadia Lymphedema Conference at which regional and national speakers presented the latest information on lymphedema to medical providers who work with lymphedema patients and also to lymphedema patients themselves. The Beth Wright Center was also the sponsor of the Turning The Tide retreat for women diagnosed with ovarian cancer. This four day retreat took place at Camp Kieve in Nobleboro, Maine

This total is the portion of the Executive Director's salary and the salary of the part-time Program Coordinator that is devoted to programs. The Executive Director is involved in recruiting instructors for programs and informing people living with cancer about the programs and services of the Beth C. Wright Center. The Program Coordinator's job is to manage the volunteer program of the Center and also to develop new programs. Her duties include recruiting, training, and supervising volunteers and scheduling activities at the Beth C. Wright Center and other locations in our service area.
