1) Give & Grow, Inc. awarded 24 scholarships this year to selected applicants. The purpose of the scholarship is to aid these individuals

in their pursuit for higher education. Each applicant was required to complete a scholarship application, submit their grades,

recommendation letters, and write 3 essays. Give & Grow's scholarship board carefully reviewed and selected the scholarship winners

There were 24 total scholarships awarded in the following amounts: 14 \$500 scholarships, 6 \$1000 scholarships, 2 \$2000 scholarships,

1 \$3000 scholarship, and 1 \$5000 scholarship.
