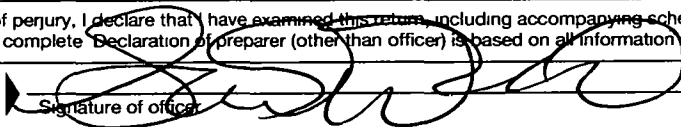

In 2013 we gave a few other smaller grants to our partners in Ghana West Africa to improve the quality of life of women and children in the areas where we work. We provided grants of \$3000 to build a gari food processing machine. The women in the community now use this to make a type of flour and sell it at the market. We started a small scale microcredit project with \$2,400. We funded women to be trained in sewing and batik for \$1,300. Additionally, we started a scholarship and education fund for girls in West Africa for \$1,225. We assisted orphans living with HIV/AIDS with \$1000 which enabled us to provide them with six months of food. Additionally we funded the purchase of milk goats in Ghana for \$767 and assisted our in-country partner build capacity with \$660.
