The Food Basket distributed over 1.5 million pounds of food last year to over 7,000 unduplicated individuals each month. In addition to the distribution of food, The Food Basket created additional security and efficiency for its operations by completing the buildout of its warehouse in Hilo. The refurbished warehouse provides additional floor and vertical space, allowing better access to products and improved receiving capabilities. The Food Basket continued its very successful Senior Farmers Market Nutrition Program, serving over 1,500 Seniors island-wide. Through other generous grants, The Food Basket was also able to expand our Keiki Backpack program from 350 individuals to over 1,100 children. Additional accomplishments include improved safety through advanced training from a third party contractor with topics including driver safety, supervisory training, forklift/pallet jack safety, heavy lifting, and others.
