FOR THE YEAR ENDING 12-31-13, THE ORGANIZATIONS PRIMARY ACCOMPLISHMENTS WERE EDUCATION, HUMANITARIAN AID, COMMUNITY DEVELOPMENT AND LEADERSHIP EMPOWERMENT. HEART FOR LEBANON OFFERED \$282,500 WORTH OF SCHOLARSHIPS FOR CHILDREN BETWEEN THE AGES OF 6 AND 12. THESE SCHOLARSHIP WENT TO 9 DIFFERENT SCHOOLS IN DIFFERENT AREAS, FROM THE SOUTH TO THE BEKAA VALLEY IN THE EAST, TO BEIRUT AND ITS SUBURBS. EACH SCHOLARSHIP HELPED THESE STUDENTS PREPARE FOR THE FUTURE AND FULFILL THEIR DREAMS. HEART FOR LEBANON STAFF VISITED EACH SCHOOL AND EACH ONE OF THE STUDENTS HOMES THROUGHOUT THE ACADEMIC YEAR. THESE VISITS HELPED TO BUILD RELATIONSHIPS WITH THE STUDENTS AND THEIR FAMILIES, PROVIDE ACCOUNTABILITY, TO ENCOURAGE AND INSPIRE THEM, TO CONTINUE IN THEIR EFFORTS OF OBTAINING A QUALITY EDUCATION. HEART FOR LEBANON, OFFERED MONTHLY MEDICAL SUPPORT; URGENT HUMANITARIAN NEEDS AND DISTRIBUTED CLOTHING. IN 2013 THE AMOUNT OF AID INCREASED FROM \$325,000 IN 2012 TO \$1,444,000 IN 2013.
