WE EXPANDED THE SEWING COOPERATIVE AND THE HARDWARE STORE PROJECT. WE PROVIDED FOUR UNIVERSITY SCHOLARSHIPS AND PROVIDED 400 SCHOLARSHIPS FOR YOUNG PEOPLE FROM PRIMARY SCHOOL THROUGH HIGH SCHOOL. IN SANTA EMILIA WE STABILIZED THE MICRO-CREDIT PROGRAM, ADDED A TEACHER TO THE HIGH SCHOOL WE SUPPORT, AND BUILT A NEW CLASSROOM FOR THE ELEMENTARY SCHOOL. IN LAFLOR, WE BUILT 30 LATRINES, PURCHASED LAND FOR A NEW HOUSING PROJECT, STARTED A MICRO-CREDIT PROGRAM, AND PROVIDED SCHOLARSHIPS TO 18 HIGH SCHOOL AND TWO UNIVERSITY STUDENTS.
