

SOLIDARITY CENTER SCHOOL, Tremesse Village, Haiti:

In 2013, Hands For Haiti continued supporting the Solidarity Center School in the village of Tremesse, Haiti. Funds were used as follows:

1) \$28,030. School operating fees (assistance to pay for teachers and staff).

2) \$7,300. Funds for building maintenance and to begin construction of a new community center (also to be used for additional classrooms).

3) \$12,133. Funds to pay for 1 meal each day for the students of the Solidarity Center School.

4) \$7,020. Funds for school supplies, school books, and internet access.

5) \$5,283. Funds for doctors' visits, medicine, cholera relief, and other medical costs for students and staff.

6) \$5,000. Funds to purchase additional land to grow crops for feeding the schoolchildren.

Line 16, Other Expenses.

\$2,275 was spent on Paypal fees, wire transfer fees and website maintenance fees (Wordpress conversion). Donations sufficient to cover all fees in 2013 were received from board members.
