What is the organization's primary exempt purpose?

Shalom Christian Missions is dedicated to serving children in need throughout the world. Our purpose is to preserve and protect the precious lives of orphans and other vulnerable children from going to waste. By caring for them in their time of need, we hope to provide them with the opportunity to become responsible and caring adults who will take the love of Christ to all nations. We are a 501(c)3 non-profit organization, dedicated to serving children in need throughout the world.

28 Children Sponsorship, Our Child Sponsorship program provides for the basic needs of the children in need, including food, clothing, medical care, education and shelter when required. We have over 100 orphans and children in need under our sponsorship care at New Beginnings Children's Center in Kenya. New Beginnings Christian School has been approved and is now registered in Kenya. There are around 360 students attending classes from Early Child Development to Class 8. Our students grade 8 exam scores continue to be the highest in the area. In 2013 the legal battle to defend and protect the children in Kenya resulted in a guilty verdict for child defilement against our ex director. He was given a 15 year jail sentence. We were also able to legally protect and defend our neighboring Widows property from those that wanted to take it from them. We were also able to legally secure and retake possession of the offices, dormitories and school buildings that were being unjustly taken from the Center.

29 Mission Experience, Our missions program provides the opportunity for individuals and groups to serve the Lord in a poor rural area of Kenya. Our sponsors have the unique opportunity to visit and serve in the area where their children reside. In 2013 our missionaries led the way in defending the children and widows in the area against the corruption and overwhelming forces against them. These included working with FASCOBI in the prosecution of the child defilement case, defending boys arrested on false charges aimed to intimidate their mothers into losing their rightful land and legally securing that land. Our missionaries continued to oversee the development of the center and school. Adding staff and organization to the growing center. We saw growing support from new local authorities, and great gains in healing within the community from the rift that was created by certain individuals trying to high-jack and personally profit from the center. The year saw several smaller mission teams of various lengths travel to the center to show Christ Love to the children and community, Our first long term missionary return home. As the year progressed we saw steady miraculous improvement in the acceptance, support and gains being made at the center.
