SCSJ meets the facts and circumstances test as follows:

SCSJ's 2013 fundraising plan was the most successful in the organization's history.

Carried out primarily by Board and staff, the plan involved a mix of grassroots

fundraising, increased use of social media to attract small donors, and outreach to major

donors. These efforts resulted in individual contributions of \$35,475, a significant

increase over the \$7,227 the organization raised from individuals in 2012. At the end of

the year our supporter database of individuals who receive email communications from us

had grown to 4,618 people. The organization's 2013 fundraising plan also included an

effort to target certain directly affected individuals to solicit donations and a campaign

to attract donors who would contribute to the organization on a monthly recurring basis.

These efforts did not immediately yield greater contributions but we have laid the

groundwork for increased funding from such programs in the future. We participated in the

"Great Human Race", a local 5K race sponsored by the Durham Volunteer Center, and held a

fundraising event at SCSJ's offices. We conducted a year-end fundraising campaign through

email and individual Board members made specific personal appeals for donations. Finally,

in 2013 we increased our fundraising efforts by working with a marketing consultant to

improve our visibility as an organization in the local community.

With regard to SCSJ's fundraising from public charities, in 2013 we sought new funding

from approximately six additional foundations who previously have not funded our work. We

were successful in attracting new funding from the Park Foundation and from Blueprint NC.

We worked with the National Committee for Responsive Philanthropy to identify potential

new sources of funding. As in past years, in 2013 we also participated in several joint

funding applications with other organizations, one of which was funded and two others that
