Nutrition Screening Pilot in India-SPOON launched a Nutrition Screen Pilot program, which included the training and evaluation of orphanage staff on the implementation of a comprehensive Nutrition Screening System (NSS), developed by SPOON in partnership with Holt International Children's Services. The NSS was implemented at Vathsalya Charitable (VCT) in Bangalore and Bhartiya Samaj Seva Kendra (BSSK) in Pune, India where caregivers were trained to identify nutrition and feeding related problems in children such as growth problems (stunting, wasting, underweight, atypical head size), anemia, feeding and eating problems (difficulty chewing and swallowing, aspiration, poor appetite), episodes of illnesses such as diarrhea and vomiting, and nutrient supplementation (iron, multi vitamins, food supplements). Six months after implementation, with the use of the NSS, anemia rates had dropped from 30% to 0% at VCT and from 45% to 9% at BSSK

Tajikistan/Central Asia-SPOON conducted a baseline nutrition assessment in Dushanbe's Baby Home #1 and the corresponding Kishit Center. The objectives of the assessment were to 1) conduct an institution and child based nutrition assessment, 2) conduct training needs assessment in nutrition and feeding for, and 3) train the staff on growth and hemoglobin measurement. Results of these assessments showed that children under 5 years in both Kishit and the baby home fell below WHO norms for all measurements. Data collected during the assessment showed that 91% of the children in baby homes are impacted by some form of malnutrition. This research was presented to Tajikistan health officials and has garnered more support from the Ministry of Health

A Child's Best Start-With the support of Joint Council on International Children's Services and as part of the Child's Best Start initiative, SPOON developed a collection of vital resources for caregivers and professionals. These resources include a "Feeding Children in Institutional Care" toolkit, as well as a "Nutrition and Feeding for Children with Cerebral Palsy" toolkit. Six feeding and nutrition training videos were also produced, including Feeding Infants 0-6 Months, Feeding Infants 6-12 Months, Feeding Children 12+ Months, and Feeding Children with Cerebral Palsy. The Orphan Nutrition website (www.orphannutrition.org) was also launched in Mandarin, expanding the reach of ON resources
