Economic Citizenship

TIGRA bundles financial and consumer services for immigrants and their families that promote social responsibility and reinvestment. In partnership with local credit unions and regional banks, secured credit card programs, accredited remittance companies, local immigrant-owned restaurants, and local food and grocery outlets that uphold labor and environmental standards, TIGRA provides "economic citizenship" education along with a suite of programs and services that exemplify the values of the organization.

Newcomer Program

TIGRA, in partnership with the Commission for Overseas Filipinos in the Philippines, reaches more than 15,000 new immigrants each year and assists them in their transition in the United States. The program includes a pre-departure orientation session in Manila and Cebu in the Philippines, and a combination of online, phonebanking and offline activities to expose newcomers to socially responsible alternatives in their transition to the United States.

Relief and Resilience Project

In response to the devastating impact of Super Typhoon Haiyan/Yolanda in the Philippines, TIGRA partnered with community-based organizations in Bantayan Island and Cebu to respond to the storm and assist in the rebuilding process. TIGRA recruited donors from the United States to support these efforts.
