We organize a project called Portland Rising that puts thousands of workers and supporters in action together. We educated people around many campaigns, including teachers fighting for a good contract, postal workers struggling to keep the Postal Service strong and their jobs an important part of the community and the economy, and the growing effort to raise the minimum wage.

Our health care work is focused on winning access to affordable health care for everyone. Our health care committee is working on educating the community and collecting photo petitions to support universal health care. The committee continues to play a leading role in Portland in educating and organizing people around the idea that health care is a human right.

Our immigrant rights committee continues to play an important role in the coalition to stop collaboration between local law enforcement and federal immigration agencies, which creates fear in immigrant communities and reluctance to rely on the police for routine public safety. We have also worked to get the state of Oregon to provide drivers' licenses to undocumented immigrants, which is a basic safety matter for immigrants and their families and for the public at large.
